To copy and paste between images, choose Edit -> Paste or Control + C, Control + V. To duplicate an image, choose Edit -> Copy or Control + C, Control + C. To create a new layer, choose Edit -> New -> Layer or Control + N. To create a new adjustment layer, choose Edit -> Adjustment Layers or Control + Alt + Ctrl + N. To create a selection, either click on a selection tool or use the Magic Wand tool. The Magic Wand tool is best for selecting an image in a similar color range. To fill a selection with a color, choose Edit -> Fill or Control + F. To increase or decrease the size of a selection, drag the selection handle. To reduce the size of a selection, hold down the SHIFT key and
